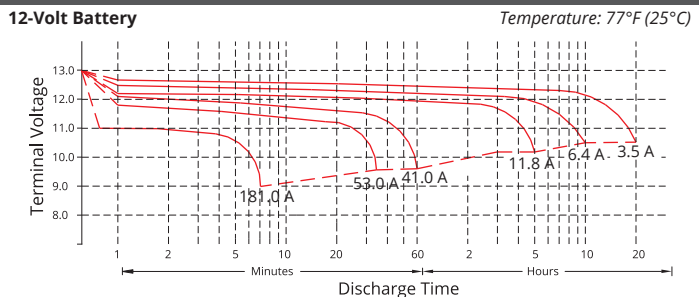

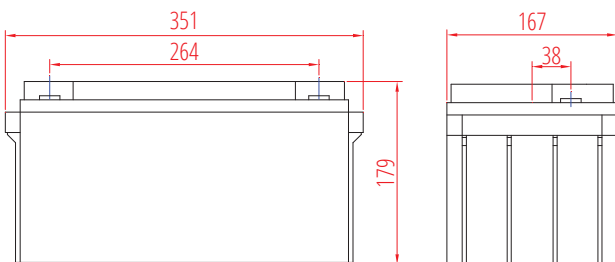

### DISCHARGE PROFILE (Constant Current)

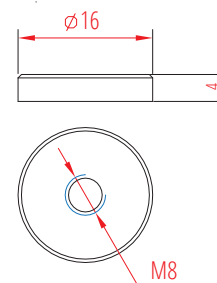

### BATTERY & TERMINAL DIMENSIONS (All units shown in mm)



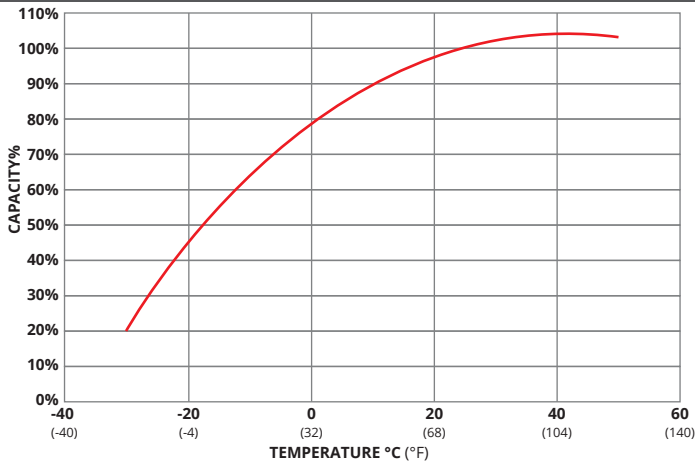

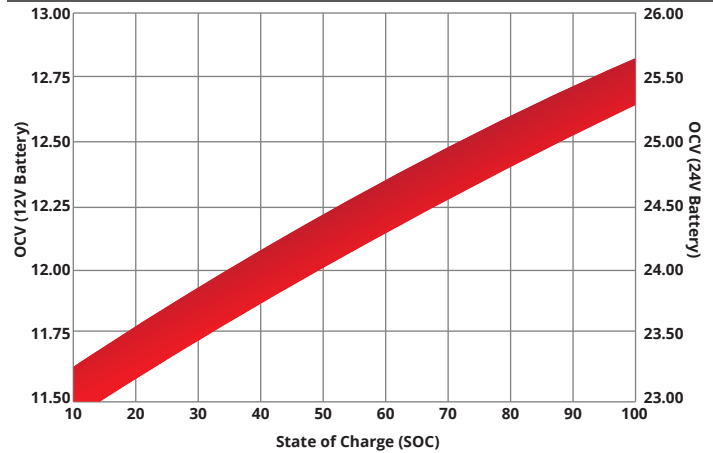

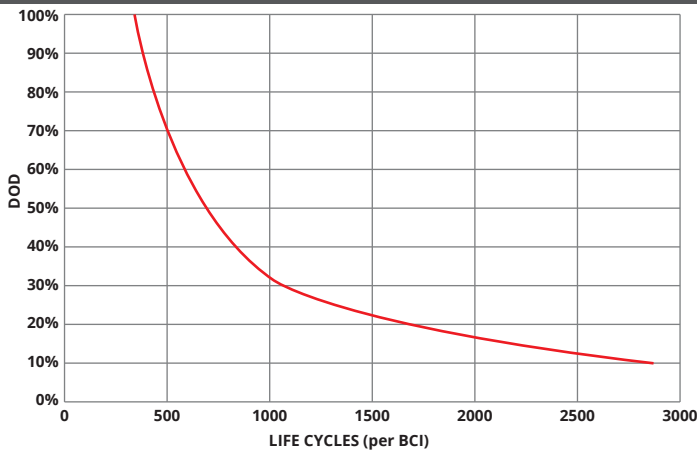
## TEMPERATURE vs CAPACITY



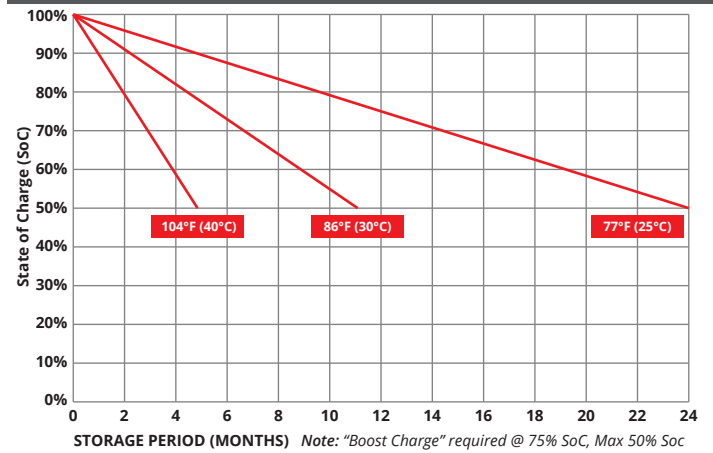
## STATE of CHARGE (SOC) vs OPEN CIRCUIT VOLTAGE (OCV)
